# Legislation updates

#### **GDPR SPECIAL:** The impact of the GDPR outside the EU

The General Data Protection Regulation (GDPR) celebrated its first anniversary on 25 May 2019. The first wave of decisions and fines has now been issued by a number of EU Data Protection Authorities and it is interesting to examine the effects of the GDPR outside the EU.

The GDPR aims to protect personal data of individuals in the EU, however, the impact of the GDPR goes far beyond the EU. In particular, if processing of personal data by a non-EU controller or processor is carried out in the context of the activities of an establishment of the controller or processor in the EU the GDPR will apply.

This is also the case in certain cases where personal data of data subjects located in the EU is processed by a controller or processor that is not established in the EU.
