Reminder: Changes to FCA's SM&CR come into effect soon

Solo-regulated firms under the Financial Services and Markets Act (FSMA) are reminded that the Senior Managers & Certification Regime (SM&CR) comes into effect on 9 December. This regime is replacing the Approved Persons Regime.

The FCA website has articles **about SM&CR** and **guidance**, to assist you in preparing for these changes.

BS7858 now includes social media screening

BS7858:2019 came into effect at the end of September and replaced BS7858:2012, which will be withdrawn on 31 March 2020.

BS7858 sets out requirements for companies carrying out background screening for employees in a secure environment.



Amongst the updates to the new standard are recommendations around the use of **social media screening**.

BSI are increasingly aware that what employees post on social media may create problems for businesses operating in secure and regulated environments.

The BSI now say: “For some roles, it might be prudent to seek additional information using best practice social media and other open-source internet checks to provide greater insights and reduce risk.”

Proposals for 'compulsory' references announced

The UK's Business Secretary, Andrea Leadsom, has put forward proposals that could make it illegal for businesses to withhold references for former employees.



The proposals are a bid to stop businesses using ‘nasty tactics’ and protect individuals who have faced harassment or discrimination.

As reported in **People Management** magazine, Leadsom said the proposals would “ensure individuals are protected, striking a fair balance between the interests of employers and workers”.
